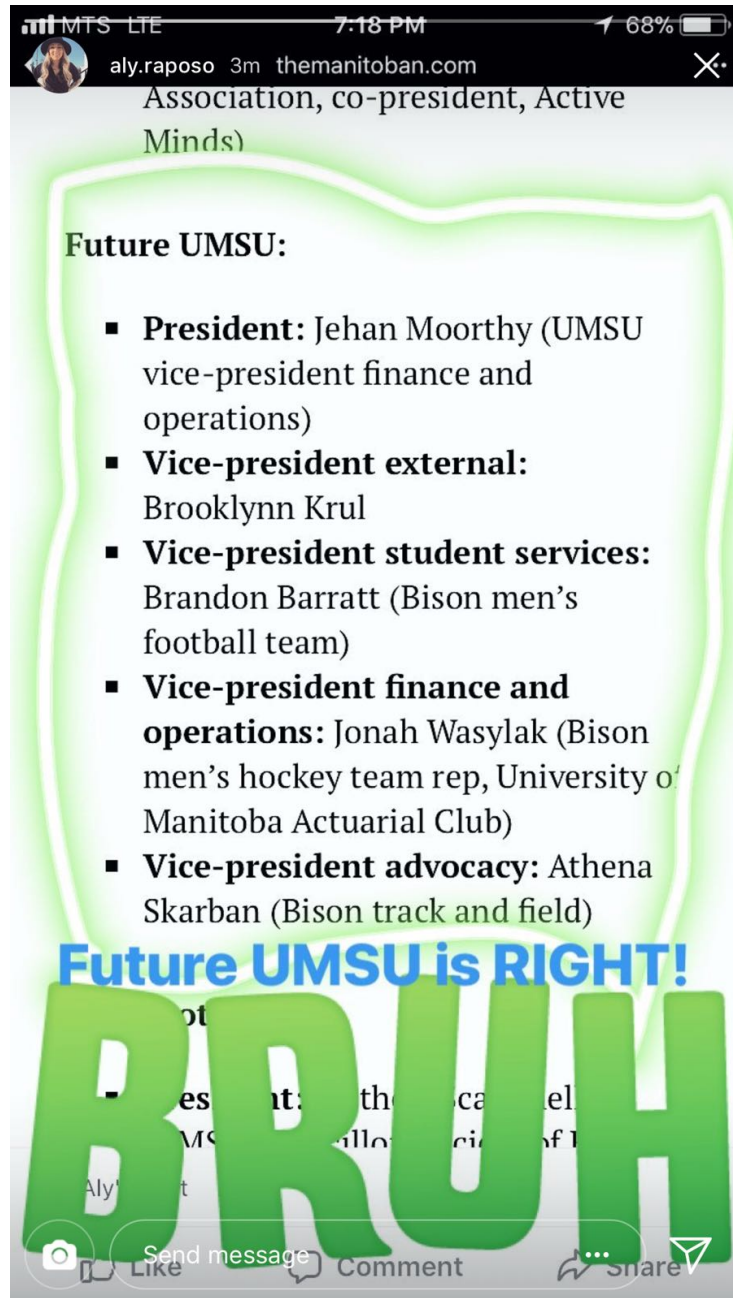

The post has since been removed. I have also attached a photo of the comment feed which the account 'aly.raposo' is publically endorses the Future USMU slate and candidate Athena Skarban. The comment has not been removed.</p> <p>This is in clear violation of UMSU's Election and Referendum Manual section V.1.g "a detailed description of 'pre-campaigning' and a list of permitted and restricted activities, which references the attached handout from the CRO at the All Candidates meeting which clearly states 'There is <b>NO</b> campaigning during the Pre-Campaign Period.' As per UMSU ERM section III.1.c 'Week 3: This week is part of the pre-campaigning period.'</p>

The complainant has issues with the post as it gives a positive message about Future UMSU to the following of 'aly.raposo', giving Future UMSU an advantage before the start of the campaign period.

The complainant provided a screenshot of the post made with the time visible at the top of the screen.
