

University of Manitoba Cardfight Vanguard Club Constitution

Article 1 – Name

The Club's Official Name will be "University of Manitoba Cardfight Vanguard Club" and may be shortened to "UMCVC". No other name will be used in advertisement or representation of the club.

Article 2 – Purpose of club

The purpose of the University of Manitoba Cardfight Vanguard Club is to provide opportunities for students who are interested or for students who want to try the game Cardfight Vanguard.

Article 3 – Membership

1. Membership for the club is open to all University students at the University of Manitoba and the public. The number of members in the club from the University of Manitoba will be at least make up 64% of the total members in the club at all time.
2. Members will pay an annual 5\$ membership fee which starts from September 1st to August 31st
3. All current members can vote in the executive election.
4. Members are expected to abide by the club rules and constitution. Failure to do so can lead to membership to the club being revoked.

Article 4 – Executive positions

There are 2 Executive positions in the UMCVC that must be held by a University of Manitoba Student.

1. President
 - Oversee the Vice-president in their responsibilities
 - Responsible for planning and managing all meetings
 - Signing authority for UMCVC
 - Point of contact for UMSU and other outside organizations
 - Manage and plan all UMCVC events
 - Bookkeep the finances of UMCVC
2. Vice-President
 - In charge of recording minutes and attending all meetings regarding UMCVC
 - Signing authority for UMCVC
 - Manage memberships
 - Assist in UMCVC events

- Manage all social platforms
- Assume the responsibilities of the President if the President is unable to.

Article 5 – Meetings

There will be a total of 2 meetings planned for all members per academic year. The president may call any number of executive meetings throughout the academic year. Meetings planned for the members of UMCVC will be announced to all members at least 2 weeks in advance.

Article 6 – Election Process

The President of the UMCVC will be elected by the members during the election period. If no one runs for the position of President, then after a second smaller election period if a President is not elected then the previous President may appoint a new President. The position of Vice President is directly appointed by the President. The election period consists of 2 parts.

1. Nomination Period
 - Nomination Period begins on March 1st and extends to March 14th
 - To be eligible to run for President one must be nominated by another member and must also be not only a member but also a student of the University of Manitoba.
2. Voting Period
 - The Voting period will be from March 15th to March 30th
 - A neutral third party will oversee the Voting Period
 - Each currently registered member can cast 1 vote for the candidate of their choosing.

Article 7 – Transition of Executives

Executive positions will be changed over at August 31st. If there is a change of position it is the departing members duty to teach the new member all their new duties and to make sure they have all the relevant information to fulfill his role.

Article 8 – Compliance with Policies and Procedures

1. UMCVC will follow all bylaws, policies and procedures of the University of Manitoba Students' union (UMSU).
2. UMCVC will be operating in accordance to the governing documents of University of Manitoba.

Article 9 – Amendments to the Constitution

1. All amendments and suggestions made to the constitution will be at planned meeting
2. Any changes made must be approved by the President
3. All members will be notified after any changes in the constitution
