We dedicate ourselves to working harder every day to strengthen the relationship between ourselves and Indigenous communities. We acknowledge the harms and mistakes of the past, and those still occurring, and vow to move forward in partnership with indigenous leaders and communities in a spirit of reconciliation and collaboration.
