New Updates

Canadian Alliance of Student Associations (CASA)

The Canadian Alliance of Student Associations serves the purpose of lobbying on behalf of Post-Secondary education students to the federal government. This last week, I was able to attend the policy and strategy conference hosted in Fredericton New Brunswick at the University of New Brunswick. As a member of CASA's National Advocacy Committee, I was able to meet and consult with individuals involved in the administrative portion of federal student loans. I was able to present the need for an increase in the Canada Student Grant. CASA has set their top three advocacy strategies for the year which were, 1) Student Financial Aid, 2) Mental Health, 3) Student housing. We were also able to discuss and strategize CASA's plan for a continuation of the international student work-limit cap. Further, we were able to discuss and strategize fair-dealing in Canada, and strategize on the actions it will take going forward.

Manitoba Alliance of Post-Secondary Students (MAPSS)

MAPSS has begun to restructure, a new board has been elected. Jagnoor Sandhu has been elected as MAPSS Secretary, Christopher Yendt has been elected as Vice Chair, and Liam Pittman has been elected as Chair. MAPSS is working on restructuring its constitution, as well as consulting with the board to determine our priorities and lobbying efforts for the year.

Student Advocacy Cases

Student Advocacy Cases have been increasing, I have been working on multiple Student Advocacy Cases, while consulting with the Student Advocacy Office. I have completed two student advocacy cases that have resulted in optimal outcomes for the student and ensuring that they have fair and equitable representation.
