New Updates

QPav

This fall, we will be working with QPay and its systems.

- QPay is a platform used for student club engagement. The platform provides clubs management, an
 integrated events calendar, wordpress widgets, e-commerce modules, reporting, finances &
 communicate, club executive customer relationship management (CRM).
- UMSU execs and full-time staff will be trained on how to use the QPay systems this summer.
- We will have club training time/day sometime in September/October to get club executives acquainted with the platform.

BAE & ACE Motion

- Working on bringing a motion to the Governance Committee to formally separate clubs and associations.
- The mandate of the Board of Association Executives (BAE) is to meet on a monthly basis to discuss issues facing student associations on campus as well as to share ideas for events, campaigns and collaborative activities.
- The mandate of the Assembly of Club Executives (ACE) shall be to facilitate communication between the Student Clubs and UMSU, and to make recommendations on Student Club issues to UMSU.
- I will wait until Governance Committee is fully oriented before bringing forward the motion, but I am hoping that ACE and BAE can be instated by September.
