6. Current Business

WHEREAS the University of Manitoba Students' Union (UMSU) recognizes the imperative need to maintain the trust of its' members and stakeholders by providing clear insights into the allocation and utilization of funds.

WHEREAS "Bison Bash" is a large, yearly-recurring event that union members, as stakeholders and the group that provides the majority of UMSU funding, are entitled to know the cost of.

WHEREAS "Bison Bash" and all associated costs have already been invoiced and expensed to their respective budget line in accordance with the Bylaws of the University of Manitoba Students' Union Section VII, (Disbursements) 31. which states that "No disbursements of UMSU funds may be effected in the absence of a completed and duly approved expense requisition form." and S.VII 32. which states that "An expense requisition form must include: a. The amount of each item contributing to the total of the disbursement; b. An invoice or receipt for each of those items; c. If applicable, reference to a duly approved motion of an appropriate governing body with the ability to authorize the expense; and d. Indication of the annual budget line item to which each expense item is to be attributed."

WHEREAS the Governance and Operations Manual of the University of Manitoba Students' Union Section VII, 49. states that "the mandate of the Executive Committee shall be to oversee and administer the day-to-day affairs of the Union, to make decisions as needed between meetings of the Board, and to represent the collective opinion of the Executive members."

WHEREAS the Governance and Operations Manual of the University of Manitoba Students' Union Section V11 line 59 states that "the mandate of the Finance Committee is to review the financial affairs of the Union".

WHEREAS the Governance and Operations Manual of the University of Manitoba Students' Union Section IV, 9. A states that "the Vice President Finance and

Operations shall be responsible for: a. Overseeing all financial management of the Union, including preparing and maintaining the budget."

WHEREAS the Governance and Operations Manual of the University of Manitoba Students' Union Section VII, 56. states that "the Executive Committee must provide reports to the Board on a regular basis."

BE IT RESOLVED that the UMSU Executive Committee create and present (to the UMSU Board of Directors) a report outlining all expenditures associated with "Bison Bash", and comparing the expenditures to the budget line for this event, as presented in the most recently approved 2023 UMSU Budget.

WHEREAS UMSU is a not-for-profit entity that practices fund accounting as per "Accounting Standards for Not-for-Profit Organizations or ASNPO [...] established by the Accounting Standards Board ("AcSB") for not-for-profit organizations. These standards are located in Part III of the CPA Canada Handbook ("The andbook") and became mandatory for not-for-profit organizations for fiscal years beginning on or after January 1, 2012."

WHEREAS Section VII (7), subsection "funds" as per the "Bylaws of the University of Manitoba Students' Union" state that:

"UMSU shall maintain the following funds:

- a. Union Operation.
- b. Business Operation.
- c. Dedicated Fees.
- d. Contingency"

WHEREAS the Audited 2021/2022 Financial Statements disregard the funds in the bylaws and instead use the:

- a. Operating Fund
- b. Scholarship and Bursary Fund
- c. UMSU Capital Fund

WHEREAS there is no use of the aforementioned Contingency Fund for "mitigating the impact of financial demands not foreseen in the annual budget" as per Section VII (7) of the "Bylaws of the University of Manitoba Students' Union".

WHEREAS there is no use of the aforementioned Dedicated Fees Fund which contains "UMSU fees levied from Members for Funding Recipient Groups" as per Section VII (7) of the "Bylaws of the University of Manitoba Students' Union".

WHEREAS the Contingency Fund would be the primary source of paying expenses related to "financial demands not foreseen in the annual budget" such as expenses related to the CFS lawsuit.

BE IT RESOLVED that the board ensure that the financial bylaws are followed prior to approving the presented 2022-2023 UMSU Audited Financial Statements.

BE IT RESOLVED that the UMSU Executive Committee prepare and present a plan for how UMSU will manage the expenses stemming from the CFS lawsuit, and explain how UMSU member fees levied from students will be used to pay for any potential losses, which have the potential to create a deficit in the current fiscal year of upwards of \$2 million.

Our Findings: The Electoral System

- The Governance Committee advises the Board of Directors to continue the use of our current Electoral System, First Past the Post.
- Here's why:
 - Less transparency in results the SimplyVoting system displays results of each round in a points system, rather than a vote count
 - Keeping consistency with all 13 elected positions if we use a Ranked Balloting System, we would need to use it for all positions which could create a general confusion for the electorate
 - Implementing the system this process would require special election education for the voter in a short time frame
 - Should a candidate be disqualified there would be no way to redistribute the results once an election has ended
