# <u>Updates</u>

### 1. Board of Governors:

Attendance at the Board of Governors meeting provided a platform for sin-depth discussions surrounding the University of Manitoba's strategic plan. The session, accessible <a href="here">here</a>, enabled an examination of the strategic initiatives guiding the university's trajectory over the next few years.

## 2. Senate Assessor Seat for IHPSA:

I connected with Jeff Leclerc, the University Secretary, to finalize the steps required to secure a Senate Assessor seat for the IHPSA proposal will be submitted shortly to the Senate Committee on Rules and Procedures. Pending approval by the committee they should have an assessor seat shortly in the New Year. This is an important step towards student representation at the U of M.
